Under New York State Law, if a defendant is convicted of a "qualifying offense," he must submit a DNA sample to the DNA Databank.

In 2006, New York added all remaining felonies and 18 misdemeanors to the list of qualifying offenses for the crimes eligible for submission to the DNA Databank.

The results of this expansion illustrate the value of taking DNA from people associated with low-level and non-violent offenses.

As this chart demonstrates:

- Samples collected from persons convicted of *petit larceny* have matched to DNA offender profiles in **41 homicides** and **203 sexual assaults**
- Samples collected from persons convicted of *criminal possession/sale of a controlled substance* have matched to DNA offender profiles in **80 homicides** and **209 sexual assaults**
- Samples collected from persons convicted of *criminal trespass* have matched to DNA offender profiles in **30 homicides** and **103 sexual assaults**
